PRIVACY NOTICE – Softgarden

- (v) Recipients of the personal data are IT service providers which we use as processors within the framework of a data processing agreement. For the usage of the Softgarden software we use the Softgarden e-recruiting GmbH, Tauentzienstraße 14, 10789 Berlin, Germany as a processor.
- (vi) All contractual and booking relevant data will be stored in accordance with tax and commercial law retention periods for a period of ten calendar years after the end of the contract. Log data are anonymized after 24 hours.
- (vii) The provision of personal data is required for the usage of the carrer website. Without disclosure of personal data the use of the website is not possible.

4. Rights of Data Subjects and Further Information

- (i) We do not use any methods of automated individual decision-making.
- (ii) You have the right to request information at any time about all your personal data which we are processing.
- (iii) If your personal data is incorrect or incomplete, you have the right to have it rectified and completed.
- (iv) You can request the erasure of your personal data at any time, as long as we are not bound by legal obligations that require or allow us to continue processing your data.
